Notice for re-opening the link for candidates who appeared in CBT for 08 categories (2, 3, 6, 7, 10, 13, 14, and 17) of Paramedical to view the questions, answers, and answer key of CBT and to register objections, if any, on questions/options/keys

A link was made available on the respective RRBs websites for the candidates who appeared in the Computer Based Test (CBT) held from 28.04.2025 to 30.04.2025 for the 19 notified categories of Paramedical under CEN No. 04/2024 to view their questions and answer keys and raise objections, if any, which was active from 06.05.2025 (16.00 hrs.) to 11.05.2025 (23.59 hrs.). It has come to our notice that out of the 19 notified categories of Paramedical, candidates belonging to 8 categories (2, 3, 6, 7, 10, 13, 14 and 17) have faced some difficulty in raising objections regarding questions, options, and keys due to technical reasons. Therefore, keeping in view the technical problems of the candidates and their convenience, the relevant link is being re-opened once again for the candidates appearing in the examination related to these categories to view the questions and options and to register objections, if any, regarding the keys, as follows:

In case the objection raised is found to be correct, the fee paid against such valid objections shall be refunded to the candidate after deduction of applicable Bank Charges. The refund will be made to the account from where the candidate has made the online payment.
