


After being shortlisted for Document Verification for the post of Technician the following candidate appeared for Document Verification in the office of Chairman, Railway Recruitment Board, Ranchi which was followed by a Medical Examination at the Railway Hospitals.

However, as per the medical report received from the Railway Hospital, he was not found fit in prescribed medical category by the three member medical committee. As per the instructions contained in Railway Board's letter No.2014/H/5/8/(Policy), Dated: 07.07.2017, he may submit appeal.

The procedure of appeal is as follows:

If any candidate wants to appeal against the decision of the medical committee, he/she should submit (i) his/her appeal to the Principal Chief Medical Director of the concerned railway within the period of one month from the date of issue of this NOTICE with due justification. The appeal so addressed to the Principal Chief Medical Director, South Eastern Railway, Garden Reach, kolkata should reach at the following address by Speed Post or delivered by hand in any working day:

The Member Secretary Railway Recruitment Board, Railway Offices Complex, Chutia Ranchi-834001 (Jharkhand)

(ii) Such an appeal shall be entertained, only if the candidate produces a medical certificate from a registered Government/Private doctor of the Speciality/Specialities in which the candidate has been found Unfit as per Proforma-A. Such certificate should contain a note that "The Government/Private Specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three Senior Railway Doctors appointed by the Government in this regard". The certificate should bear the photograph and marks of identifications of the candidate duly attested by such a Government/Private issuing authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and his/her Medical Council of India/State registration number.

If you wish to appeal against this medical verdict, kindly send your appeal as indicated above to Railway Recruitment Board, Ranchi by 09.10.2025 with the following three documents.

- (a) Appeal with justifications duly signed by the candidate indicating his/her Roll No., Registration No. and date of Document Verification as Annexure-'B'.
- (b) Medical certificate issued by Government/Private Specialist as per the format enclosed as Annexure-A.
- (c) A Demand Draft for **Rs.1000**/-(Rupees one thousand only) in favour of **FA & CAO, South Eastern** Railway, Garden Reach, Kolkata.

(b) Proforma for appeal as Annexure-'B'.
